Child Registration Form and Parent Agreement/Contract

(Effective Sept 2, 2019)

Registration Fee is \$100 for the first child and \$25 for each additional child in the same immediate family. This is an annual/yearly fee due in September. (Non-Refundable)

Weekly Tuition Rates

Full-Time Students: Infants, Toddlers, Preschoolers and Pre-K

Infants and Toddlers - \$270
2 year olds - \$200
3 and 4 year olds - \$190
5 year olds (all day) - \$190

School Age Children

Before and After School - \$135 / Out of school for a full week - \$175
If school is out for a full day, then a \$10 extra fee will be charged for that day.

(Never over \$175 a week)

Just Before School or Just After School - \$100

Part-Time

2 Days - \$100
3 Days - \$145
4 Days - \$175

(Tuition is Non-Refundable)

Discounts - \$10 off for any additional child in the same immediate family

Drop ins - The rate for a drop in is \$60. (Payment by Cash, Debit Card or Credit Card Only)

Drop ins must be two (2) years old or older, No infants-No toddlers

Happy Faces Early Learning Center--continued Parent Agreement/Contract

I agree to pay tuition every Monday morning prior to leaving my child at Happy Faces. I understand that I may pay by Cash, Money Order, Cashier's Check, Check, Debit Card, or Credit Card. If tuition isn't paid on Monday, I understand that my child will not be able to attend until their tuition is paid in full. Tuition will still be due for days my child isn't attending, up to two weeks. After the two week period, my child will no longer be enrolled at Happy Faces. I may only re-register my child after my account has been paid in full. If a collection agency or litigation is necessary to collect unpaid tuition or other debt, I will be responsible for all court costs, attorney fees, and any other fees included.

Photographs will occasionally be taken of children for families to see their child at play/work and for promotional purposes. Photographs may be used on Happy Faces E.L.C.'s website and/or on Happy Faces Facebook page. If you do not want their picture taken at all, written notice must be provided to management.
